- 4. Special Delivery Bags:** We employ specialized delivery bags designed to preserve the integrity and temperature stability of medications during transportation.
- 5. Ample Storage Space:** Our facility provides ample storage space where we store goods on pallets, ensuring efficient organization and easy access to medications.
- 6. Fire Safety:** We prioritize the safety of our facility and personnel by implementing robust fire safety measures, including fire detection systems, firefighting equipment, and regular safety drills.
